Meeting Dates

- The Decennial Committee met three times in accordance with the Open Meetings Act. Public comment was allowed at each meeting, and residents were surveyed afterwards, via email, asking for their input on matters discussed at the meeting.

Findings/Recommendations

The following recommendations are offered by the Decennial Committee for consideration by the Board and Board Policy Committee, the College Administration, and offices responsible for reviewing, developing and implementing policies and procedures related to the use of Waubonsee Community College facilities and services by external partners. The recommendations should be taken under advisement as policies and procedures are revised or developed for use of college facilities and services:

- Connect and align all policies to applicable standards and procedures for decision-making and implementation.
- Develop categories of groups and events that will provide transparency and assist with decision-making on how the College will approach requests for the use of college facilities and services.
- Adopt a more inviting approach to making facilities and services available to groups and events with existing or pending strategic partnerships.
- Develop a fee structure that is clear and may differentiate costs based on strategic partnerships between the College and requesting parties.
- Develop a process that will provide guidance for determining how facility and service requests are prioritized.
- Develop criteria for what types of behaviors and activities may be prohibited based on codes, laws, and potential harm to the College.
- Craft a statement (a "preamble" or "purpose statement") for the policy which expresses the College's desire to serve the community but also balances respect for expression with the business and mission of the College.

These recommendations will be shared with the committees and persons involved in the review, revision, and development of policies and procedures. There was consensus among the group that

there will be value in addressing these policies and procedures in a timely manner. All policies and procedures revised or developed will comply with all federal, state, local laws and ordinances.

Dissolution of the Committee

After the report is submitted to the county boards, the Decennial Committee is dissolved. However, the Act requires Waubonsee Community College to appoint a new committee and repeat the process every ten years.
